Rangers also carry 2-way radios.</p>
<b>Potential tree zones</b>	<p>There are several large trees around The Rocks precinct. Trees are maintained by qualified horticulturalists and arborists.</p>
<b>Other factors that may be relevant to risk management</b>	<p>As this is an outdoor programme, it is recommended that students wear comfortable walking shoes as well as sunscreen and hats. Wet weather gear will be necessary on rainy days as the programs will run regardless.</p>
